

**Public offer agreement on services for the organization of participation in the conference International
Conference on Engineering Research and Applications 2019 (ICERA 2019)
24-26 October 2019**

Russian Federation, Moscow

1. This public offer agreement is an official offer of INTEGRITIS LLC (hereinafter referred to as the Contractor) to provide services on organization of participation in the Conference and facilitate publication of materials sent by an individual (hereinafter referred to as the Customer), who will accept this offer on the terms of the Agreement.
2. The Contractor shall organize the Customer's participation in the Conference and provide services to facilitate the publication of materials sent by an individual in the journals indexed by Scopus or Web of Science.
3. The Offer is accepted by the Customer and the Agreement concluded when the application for participation in the Conference is received and the payment for the services is made.

The Contractor undertakes to:

1. Organize participation in the Conference;
2. provide the Customer with a participant kit (in case of in-person participation), organize lunch and coffee breaks;
3. assist in publishing materials in journals indexed by Scopus or Web of Science, i.e. review the submitted comments by scientific editors, check the correctness of the design and send them to the journal.

The Customer undertakes to:

1. Pay for the services of the Contractor according to the cost specified on the website <http://icera2019.ru> and the invoice by making a 100% prepayment to the banking account of the Contractor;
2. send a written refusal to the Contractor within 15 calendar days prior to the Conference (by e-mail) in case of refusal of participation in the Conference. In case of refusal at a later date, including the absence of participants at the Conference, the cost of the services shall not be recalculated, and the payment shall not be refunded;
3. Fill in the application form, draft materials in accordance with the sent template, notify the Contractor about the presentation of materials at the conference in person.

Final terms

1. The Contractor has the right to take audio, video and photo shoots in the framework of the Conference, which can be used for any purpose.
2. The Customer and its participants shall not be allowed to make a video recording without the special written permission of the Contractor.
3. All disputes and controversies arising in the performance by the Parties of their obligations under this Agreement shall be resolved through negotiations in the complaint procedure.
4. If the parties fail to resolve their disputes and controversies through negotiations, such disputes and controversies shall be considered in court at the location of the Contractor. Applicable law is the law of the Russian Federation.
5. Without contradicting the above, the Contractor shall be released from liability for breach of the Contract if such breach is caused by force majeure, including: actions of public authorities (including adoption of legal acts), fire, flood, earthquake, other natural disasters, lack of electricity and / or computer network failures, strikes, civil unrest, riots, any other circumstances, not limited to the above, which may affect the performance of the Contractor.

Accepting this agreement and paying for the services of the Contractor the Customer agrees with the Policy of personal data processing located at www.icera2019.ru website.
